# **County News**

#### **Training**

As with so much else training in Hampshire in 2020 has been a disaster with none of the plans I had coming to fruition. We can but hope that 2021

will see a return to something resembling normality and I will certainly do my level best to try to catch up and provide the training that I know so many of you need. It is my sincere hope that the provision of training in the future will prove to be much more streamlined and user friendly. While the rest of the populous was fighting over the last multi pack of toilet paper and trying to squeeze another packet of dried pasta under the stairs, we in the Membership Training department have been quietly working away modifying not only the way that training is presented within the Legion, but also developing new and improved training modules and content.

The work associated with the Training Review began over twelve months ago and was due to be completed by October 2020. Due to the limitations imposed by the corona virus situation this proved unachievable so the decision was taken to extend the completion date to April 2021. We are currently on track to complete the proposed work by this revised date. The purpose of the review was to modernise the way that training is presented in the Legion and to provide a platform that enables more members to have access to training. It was decided at an early stage that we should develop training that can be moved online in parallel with the physical face to face training. To this aim an existing online training platform has been chosen which is being modified to make it more relevant to our needs. As well as utilising some of the generic training modules that come as part of the package with the training platform, bespoke RBL training courses are being developed which will be divided into a number of modules, each module being of about 90 minutes which is the time it is considered an adult can comfortably spend in front of a computer screen at one time. As these training courses are being developed, they are being presented to the Validation Panel to ensure there are no further delays to the platform going live.

In parallel with the new online training platform, we will also be holding certain physical courses for those who prefer to receive their training face to face. This will include the one-day Branch Management and Branch Treasurer courses. As these are courses, we can hold locally in the county there is no reason why we cannot run courses at individual branches provided there are enough delegates. It is my considered opinion that all branch officers and where appropriate all

committee members should attend these courses in order to learn what their roles and responsibilities are in accordance with the Royal Charter and the Membership Management Manual. This should also be considered as a refresher for those who received their training some time ago.

Obviously no physical training can take place until we are given the go ahead, but be sure that as soon as that happens then I will do my level best to get the ball rolling to enable 2021 to be a much more successful training year that 2020.

Finally, I would remind branches of my offer to hold MAP's and Office 365 workshops for branch officer and committee members in individual branches. With more and more Legion activities and information migrating online, now is the time to embrace this technology knowing that we are here to offer help and support to get you started. # Centennial of the RBL Brief History Lesson

The Royal British Legion has been supporting service Men & Women, ex-serving personnel and

their families since 1921, and we are not planning on going anywhere.

the British Legion was formed 15<sup>th</sup> May 1921, bringing together four national organisations of ex-Servicemen that had established themselves after the First World War:

- The National Association of Discharged Sailors and Soldiers
- The British National Federation of Discharged and Demobilized Sailors and Soldiers
- The Comrades of The Great War
- The Officers' Association

The amalgamation of these diverse bodies can be attributed largely to two men: Field Marshal Earl Haig and Tom Lister of The Federation of Discharged and Demobilized Sailors and Soldiers. Lord Haig served as the President of The Royal British Legion until his death.

As a result of the war, Britain's economy plummeted and in 1921 there were two million people unemployed.

Over six million men had served in the war, of those that returned, 1.75 million had suffered some kind of disability and half of these were permanently disabled.

Then there were those who depended on those who had gone to war – the wives and children, widows, and orphans, as well as the parents who had lost sons in the war, on whom they were often financially dependent.

The Legion was established to care for those who had suffered as a result of service during the First World War. And we've been helping the Armed Forces community and their families ever since.

#### Eligibility

We're dedicated to supporting not only serving and ex-serving personnel but the whole of the Armed Forces community, including dependants and carers. This includes:

- Serving personnel, or those who have previously served, who have received seven days' pay and were aged 16 or over at the time of service
- Reserve or Auxiliary personnel, or those who have previously served

- Those who have served with the Mercantile Marine afloat in hostile waters
- Current or previous full-time members of Allied Civil Police Forces
- Those entitled to the campaign medal issued to the Royal Navy, Army or Royal Air Force to those giving them direct support or under their command
- Any member of Voluntary Aid Societies who has served full-time and in uniform in direct support of the United Kingdom **Armed Forces**
- Any British subject (by birth or otherwise) who has served at least seven days in the Forces of an Allied nation during hostilities and received seven days' pay from that nation
- Any British subject (by birth or otherwise) who served in a resistance organisation of an Allied nation during hostilities in which the United Kingdom Armed Forces were engaged
- Any person who served in the Home Guard for at least six months, or in a Bomb and Mine Disposal Unit for at least three months
- Any person who was awarded the Defence Medal in respect of service in the Home Guard or in a Bomb and Mine Disposal Unit

We can also provide support for Commonwealth citizens who are residents in the UK as well as past and present members of the Brigade of Gurkhas and their families.

The Royal British Legion will be celebrating its 100<sup>th</sup> year in a number of ways this year, and Branches are requested to let the Area Office and County Fund raisers of any events that they are planning, so the full support of the RBL is available.
