National News

Parades

As many Branches celebrate or plan their centenary and some work on Remembrance events, we wanted to reiterate the Legion's policy about road closures for parades. The Legion does NOT own or insure road closures (known as Temporary Traffic Management Orders or TTMOs). That is because the law relating to the safe deployment and removal of a TTMO is complex and should be left to local authorities or the police, who are the experts.

The policy is set by the Board of Trustees and reads as follows:

- Remembrance events should, wherever possible, be organised by a Civic Authority. All aspects of an event that is organised by a Civic Authority should remain the responsibility of that Civic Authority. Temporary Traffic Management Orders ("TTMOs") may only be organised and deployed by the Civic Authority and on no account should RBL staff or volunteers be deployed to manage traffic;
- Where RBL must be the Event organiser (because the Civic Authorities refuse) RBL may take this role but **there can be no street Parade, no road closure and, therefore, no need for a TTMO** unless this aspect of the event is owned by a Civic Authority. Whilst the branch can be involved in determining a Parade route, it should not itself contract with a third party and may not take responsibility for the design, planning and deployment of a TTMO; and

• On the day of the Parade, RBL and its volunteers must not engage in the deployment, management or removal of any TTMO. This includes, for example, placing barriers, directing traffic or driving vehicles that are involved in the TTMO.

This policy is not new but we want to bring it to your attention as the result of a serious road traffic accident at the 2018 Remembrance event, which resulted in a multi-million-pound personal injury claim against the Legion. We must do all we can to ensure such accident does not happen again. Any branch organising a TTMO (or takes to the road without one) is uninsured for that parade. Many Remembrance events now take place without an on-road Parade. As local authorities continue to seek ways to cut costs it is likely the proportion of "static" events will only increase. There may also be a need for branches to merge Parades with other branches. No branch may extend the Legion's Public Liability cover vicariously to a civic authority or other third party. The Branch CAN share the Legion's PL certificate on request. The latest insurance certificates are available on MAP.

Public Policy Team are writing to all local authorities as they did before, to remind them of their civic duty.

Ringwood

The Re-dedication therefore eventually took place on Sunday 15^{th} August.


The opening of the event began with the Welcome and Introduction by Councillor Tony Ring, Ringwood Town Mayor and Mr. Chris Wilkins, Ringwood Town Clerk. Appreciation was expressed to the Councillors and Officers for support throughout the conception and fulfilment of the Project.

The Ringwood and District Branch of the Royal British Legion was attended by members and we were also delighted to welcome Tim Russell, County Chairman and Avril Mitchell County Committee Member. Andy Cassidy (Aldershot Branch) carried the County Standard. Dave Graham carried our Branch Standard and his wife, Karen, also from the Milford on Sea Branch, carried the Milford on Sea Women's Section Standard.

The service, which took place in the War Memorial Gardens, on the corner of Mansfield Road and Christchurch Road, started at 11.30am with live music from the Ringwood and Burley Band. The service of rededication, which was live streamed to the Ringwood TV Facebook page, began at 12noon with introductions from the Town Mayor, Cllr Tony Ring and Town Clerk, Chris Wilkins. The Rev. Terry Roberts, Chaplain to the Ringwood Branch, lead the short service during which all the names recorded on the memorial were read out, by members of the Council, Guides, Scouts, RBL, Church and Rotary.

Rev. Terry Roberts had also been very much involved in the preparation for this event. The Ringwood and Burley Band attended and played a selection of music before the Service, accompanied the hymns and continued to play a selection of music afterwards.

The refurbished Memorial is a fitting tribute in memory of those from Ringwood who gave their lives in both WW1 And WW2.

RAF Seletar & Tengah Association's

The purpose of the Association is to bring together former comrades who served in Singapore and by organising an annual reunion and regional gatherings foster new friendships. Membership is open to all RAF and civilian personnel and their relatives who served at any station on the island of Singapore. Also included are past and present personnel of the Singapore Armed Forces who serve/served at Seletar and Tengah bases and Members of the Seletar Flying Club.

RAF SELETAR

RAF Seletar operated between 1928 and 1971. Initially with flying boats and then the addition of Vickers Vildebeest. Seletar was occupied by Japanese forces from 1942 to 1945. During the Malayan Emergency Seletar was heavily involved until 1960 and again during Confrontation with Indonesia. The RAF withdrew in 1971;



RAF TENGAH

RAF Tengah was commissioned in 1939. In 1942 it was occupied by the Japanese Army Air Force but was re-occupied by the RAF in 1945. Tengah was involved strategically during the Malayan Emergency and Confrontation with fighter and bomber aircraft. In 1971 it was renamed Tengah Air Base and handed over to Singapore Air Defence Command. From 1971 to 1976 it was part of ANZUK which comprised of AUSTRALIAN, NEW ZEALAND and UNITED KINGDOM forces.
