Spring Circular

Keynote Speaker Professor Gavin Oxburgh

On the Sunday and closing day of Conference, we will be joined by our keynote speaker, Professor Gavin Oxburgh. Professor Oxburgh is a registered forensic psychologist, a chartered psychologist, scientist, and a professor of police science. He is the Assistant Director of the Northern Hub for Veteran Military Families Research based at Northumbria University Newcastle. He is a registered expert witness, providing advice on legal cases in the UK and overseas. Working in close collaboration with many police forces and law enforcement agencies around the world he also provides specialist advice and training to the investigation division of the International Criminal Court (ICC) at The Haig and sits on a UN led international Steering Committee. A 22-year military veteran he served in the RAF Police as a senior detective. He is also a member of the Royal British Legion.

Charter Motions

County Youth Officers

In February, County Youth Officers (CYO) completed the Community Development Team's Youth Survey. Following on from this, we're now inviting CYOs to attend a 90-minute online session ahead of Annual Conference on **Wednesday 26**th **April 19:00-20:30** where we will:

- Present the One Legion Youth Strategy.
- Feedback findings from the CYO survey.
- Provide an opportunity to discuss both the strategy and your comments from the survey in more depth.

Volunteer Expenses

The volunteer expenses form states that by submitting the form members confirm that they have a valid driver's licence, road tax, MOT and insurance which covers business use. If you are using your vehicle to carry out any volunteering activity, you must check with your insurance company to make them aware. Some car insurance companies require you to state if you are using your car for business use, which volunteering would fall under. This will ensure that you are covered when using

your car for any RBL activities. It often costs nothing to add business use if your insurance company does require that you have it.

The King's Coronation

The Royal British Legion is honoured, on behalf of the Department for Culture, Media & Sport, to offer our veteran community a limited number of tickets to observe part of the ceremonial procession for the Coronation of Their Majesties King Charles III and Queen Camilla on Saturday 6 May 2023.

The tickets will allocate you and a guest seats within the Grandstand situated by the Queen Victoria Memorial, which will be an excellent viewpoint for the processions and military manoeuvres, as well as a view of the balcony and flypast.

- Estimated timings below.
 - o 06:30 Gates open
 - o 08:30 All attendees must be seated
 - o 09:00 Military movements begin
 - 14:30 End of event

Please note it will be a long day, sitting outside with no opportunity to exit and re-enter the grandstand zone once inside. You are of course free to leave early should you wish. There will be toilets, water, and refreshment facilities within the zone to purchase food and drink, you can bring your own food and drink. We recommend you bring sunhats, sunglasses, umbrellas as the grandstand is a fully open tiered seating structure.

There will be audio of the ceremony available over speakers, **but no large screens** to view the service.

Those that are successful will receive a confirmation email week commencing 17 April directly from the event organiser.

An entry ticket (a QR code and optional print-at-home PDF) will then be sent to the same email addresses 1 week before the event. This will contain full joining instructions including walking routes, confirmed timings and what to bring.
