#### **County Accounts**

The independently examined County accounts for the year to 30 June 2021 are summarised in this report. For comparison, I have also included the accounts for the year to 30<sup>th</sup> June 2020.

Despite the easing of COVID-19 restrictions post the third national lockdown, County expenditure on activities has been minimal (the only expenditure was £30 to the Nailsworth Silver Band who provided a bugler at the 2021 Anzac Day ceremony and £510.83 for Almonisation) and has remained at an all-time low as was anticipated. Funds originally earmarked for the County Plan 2020-2022 were carried into the County Plan 2021-2023.

The ring-fenced portion of the account to 30 June 2021 increased from £3,245.81 (as was reported at the last years County conference, this figure already included funds from Tetbury branch's bank account) to £5,532.34 due to the referral and subsequent acceptance of three branches for CSB status. Further detail on this is contained within the section below.

I would also like to thank Gloucester City and Lydbrook branches, who responded to our previous Chairman's call for contributions to County funds at the 2020 Conference. A further £387.60 was received, which will support the County Plan 2021-2023. Subject to the impact of the COVID-19 pandemic dissipating, the budgeted spending over the next three years is planned to be £11,230. In line with guidance contained in version 1.3.1 of the Membership Management Handbook, permission was granted for the balances held within the County accounts at HSBC to be transferred to a new account with Lloyds Bank and the HSBC accounts to be closed. This has enabled County to take advantage of internet banking via the Legion's corporate internet banking platform. This facility has already helped streamline expenses payments.

#### Yate, Sodbury & District Loan for GP90

Following the last County Conference, a number of contributions from branches were received in support of settling the loan for branch members to travel to Belgium for GP90 in 2018 that was made available by County Committee to Yate, Sodbury & District branch. With kind thanks to Gloucester City, Hardwicke, Stoke Gifford and Thornbury branches who contributed to supplement Yate, Sodbury & District branch's own contributions, this loan is now considered to be settled.

#### **County Supported Branches**

During 2020/2021, County Committee referred and then subsequently successfully accepted three branches for CSB status. The accounts held by Bibury & District, Tetbury (as was declared at last year's County conference) and Wotton branches were closed with monies transferred to be ring fenced within County accounts. A further two branches (Bisley and Minchinhampton) were referred for CSB status, but actions had yet to conclude when 30 June 2021 year ended.

#### Training

Due to the roll out of the Legion's new Learning Management System in 2021, release of LOMAS training was delayed, but would like to thank HQ Staff and MSOs for their support in getting up to speed with the role and system in the interim. Training is now being released and this has been undertaken.

James Brimble County Treasurer Due to Covid-19, training at both National and County levels have been altered in the way it is delivered. There is still face-to-face training when infection levels allowed the training to go ahead. There is now a mix of online via video link or by the Royal British Legion's Learning Management System (LMS), which is how many of the National level courses are being delivered. This has the advantage in that it allows the individual to work at a time that suits them.

Since I came into the role last year, I still have not been able to get the training required for this position, I have been doing the role supported by those on the County committee who have been in the past. I was able to find the date for the National virtual seminar, which allowed for our County Recruiting officer, County Youth officer and myself as County Trainer to attend. This was not training for the roles. It did help in allowing us to see the challenges we were facing and how Head Office expected us to deliver and grow in these roles.

All County Training courses now are required to be applied for via the local training calendar. Which then puts you on the Membership App. Which all Branch Chairmen and Secretaries have access to once they have activated their Branches RBL.community email address. It is a requirement now that all County delivered training is put onto this system, this includes in-person training.

Treasurer training is the most requested training by a Branches, within the County. This can only be taught by National Trainers. It was one of the courses that now have been changed to the LMS, and I was able to get those interested onto the training through the National Trainers. Unfortunately, this does not allow the for question to be raised at the time of completing the course.

A Branch Community Support Rep (BCS) within the Branches is now necessary. Everyone who holds the position must receive training. There was awareness training given earlier this year and I was able to get several Branches through to the virtual session. The Branch Reps then must receive training, which is given via LMS, this has to be applied for through the MSO as a DBS certification is a requirement for those who become BCS reps. I am aware that a few Branch BCS reps have now also completed LMS training.

In the short period where I was able to get to do in-person training. We were able to do one session of Branch management training. This was well received. We were planning for a further session, when, we were informed because of Covid-19 only online training was allowed. Several Counties are now only doing on-line training.

My term on County Committee has come to an end, and due to my commitments, I will not be standing for a position on County Committee again.

#### Appendix F: County Community Support Officer report

The last year has been an eye opener for me with BCS portal on maps 0365. At the last AGM the County came out joint bottom of the table for reporting what we do on the portal on 0365 in respect of Welfare. To be fair to all "Welfare" which we all have been doing, took a big change with Area offices closing and more effort was required by Branches in what we now call Branch Community Support (BCS) although to start with this has been rolled out badly in my opinion and Branches were not given the correct info about these changes.

Going forward to mid to late 2020 It became obvious that this was going wrong, and Matt Ford and two other staff members came on board to try and improve the BCS for the RBL and bring it out so all branches can take part. There are Four main headings that the Legion are looking at: Remembrance, be sides our normal parade on the 11/11/ at 11o'clock each year, we want you to record when your branch standard is used for funerals, when members attend even if it is only one member with or without the Standard being present at a funeral. Telephone Buddy, we know you have members calling members and we also know that you call other veterans who are not members, but we need the amount of phone calls recorded in your branch minutes and on the Portal. Visiting, we would like you to do Home and Hospital visits When allowed Covid19 permitted these also need to be reported on your minutes and on the portal Remember DATA Protection and Lone working when taking up these rolls, a small amount of training is required for these visits, and it is for the visitor(s) Benefit and the beneficiary benefit as well. 2 to 3 hours of your time is the requirement for this training. When selecting or asking for a volunteer from your Branch to become your BCS representative please make sure they have access to a computer/laptop to do the reporting.

In October I attended a Three Counties meeting in Worcestershire for an update on BCS with Matt Ford this was well represented as far as Matt was concerned with Chairman of Worcestershire and our MC rep Garry Mills hosting, we were not well represented from the county which was a shame, however we then set up an identical meeting on the 29 November in the morning it was at Cheltenham branch RBL sadly only the Host Roy Roberts and Jane Jennings from Cam and Dursley Branch were there ,in the afternoon we moved to Stoke Gifford Branch when we had Stoke Gifford , Staple Hill , Thornbury branches sending reps along and a good meeting was had. I propose to do this again in middle to late February this time I would be doing it on a Saturday. Would like to ask Cinderford and Cirencester to host, if possible, not necessary on the same Saturday. Again, both locations are for all BCS reps to attend one or the other in the same way November meetings was held. If your rep is not available, please try and send Chairman or/and Secretary.

We need to improve our County up the ladder and set examples to all the Counties I can only do this with your help.

We know we have done this in the past, so it is not new to anyone we just now need to improve how we report it.

#### MOTION FOR CONFERENCE

CHELTENHAM & DISTRICT BRANCH BR3030 wishes to submit the following Motion:

This Conference challenges the current policy of Head Office Finance Department in relation to its actual and planned disbursements from Area Trust Funds (ATFs) and the lack of visibility of such transactions, particularly relating to the South West Midlands (SW Mids) ATF. Finance Department should publish to branches each May, through respective Area managers, clear details of the annual income and expenditure from the relevant ATFs.

#### REASON FOR INCLUSION:

Entries relating to Area Trust Funds (ATFs) in the RBL Annual Report for year ending 30 Sep 2020 are shown on page 88 (Note 28) under Group Restricted Funds - Area Trust Funds. The Balance figure quoted as at 30 Sep 2020 was £29.4M noting "Resources expended £11.SM; transfers £2.02M".

Head Office advises that Finance Department manages the Area Trust Funds and allocates welfare expenditure to them at the end of the financial year, based on what has been spent in each area. There is no information available to readers of the Annual Accounts, or subsequently, as to where £11.8M has been expended, nor from which ATFs such funds have been utilised, nor what the items of expenditure related to or to where they have been transferred "for wider use". There is no published policy or process giving branches, or County Committees, the facility to consult regularly with Finance Department to identify ATF funds available or plans for such use. Despite repeated requests through the appropriate channels since June 2021, no information requested by this branch relating to the SW Midlands ATF has been received. <u>EFFECT IF PASSED:</u>

County Committees and Branches will be better informed in a timely manner as to the wider plans of TRBL both nationally and regionally and can consider such plans when making their own decisions to apply for funds for use in the best interests of beneficiaries and members in their locality. Moreover, branches, through County, can inform Area Managers and Head Office of opportunities to benefit members and beneficiaries, thus TRBL plans for utilisation can include adequate consultation with members affected.

#### MAIN ARGUMENT

Despite a request in June 2021 to the (since departed) Area Manager SW Mids and the stand-in AM + in Sep 2021, there has been no visibility available to local branches in Gloucestershire County - that we are aware of - of the status of the SW Midlands ATF. Head Office Helen Downie (Chief Finance Officer) advised stand-in AM+ by email on 11 Sep 2021 that in respect of Area Trust Funds, *"Finance manage the Area Trust Funds – we allocate welfare expenditure to them at the end of the financial year, based on what has been spent in each area. We do this annually as this is the most simple and efficient way to do it. We are drafting an update for Membership on Area Trust Funds and how they are spent. I'm hoping to get this out next week – it has been sitting with Internal Comms for a while, we are currently chasing for a final version".* 

Nothing had been heard from AM+ or Head Office Finance by 15 Oct 2021 and no sight of the promised explanatory update, and so this Motion was unanimously agreed at this Branch's AGM 16 Oct 2021. The required information to be provided by Head Office should cover ATF balances at the start and end of the current financial year (FY) in accord with national accounts data, details of expenditure during the FY and planned and anticipated expenditure for the forthcoming FY. This information should be updated annually, and it is strongly recommended that details of the SW Mids ATF should be made available to the 3 County AGM Conferences as part of the Area Manager's Report in time for the next round of such Conferences in Jan/Feb 2022.

Publication of the policy and procedures for the management of ATFs at Area level is urgently required and must be easily accessible. Branches are <u>generally</u> aware of the existence of ATFs and their ability to apply for support, but the criteria are not clear (lacking accessible publication and were not known to Area Manager SW Mids when in post) and importantly the lack of detail on how the ATF is being used does not help branches decide whether any potential application for support is appropriately targeted towards the ATF funds.

Motion	"We would like clarification from the RBL regarding the current status of breaks for beneficiaries. When the RBL decided to close break centres/hotels we were assured that beneficiaries would be able to apply for breaks as before, but the RBL would look at private accommodation as this would reduce costs. Since then, we have tried to use this process and have found the process is non-existent, therefore we would like clarity."				
Reason for inclusion	There seems to be varying statements from staff and volunteers of what we can offer as a charity since the closure of the hotels/break centres.				
Effect if passed	RBL members, branches and staff will know exactly what we can offer and deliver since the closure of the hotels/break centres.				
Main Argument	One of our first BCS cases in April 2021 was a veteran who called us saying he needed some respite. We contacted the national call centre and was told that the RBL could no longer help as their hotels had now been closed. Our chairman advised that this is not what was agreed by the RBL and that the RBL advised in town halls and meetings following the consultation, that the charity would still be able to offer assistance but through other providers.				

After much going back and forth several times, the RBL advised that they would be able to help.

By the end of July 2021, the RBL advised that they would need to do a financial check on the beneficiary but by this time he was no longer interested in assistance from the RBL.

Following this result, we asked for meetings with the Area Manager, the staff member dealing with the case and our Membership Council rep, a meeting was arranged but was cancelled by the then Area Manager and has not been rearranged despite several emails and attempted calls to all involved. Sadly, we have been ignored.

Our branch feels rather let down in this case and sadly we have noted that the member that reached out for help has not renewed his membership. However, we regularly keep in touch to make sure that he is well.

We don't want this to happen again to any other beneficiary and therefore would like the RBL to give clarity on this matter to all branches.

#### Appendix L: Corporate Address 2021-2022

#### RBL 100/Centenary

- As our name reminds us, the Royal British Legion is made up of many parts. And as you know, we were formed 100 years ago when four separate organisations came together because they realised they could do more good working together as one Legion.
- This year we have marked our centenary 100 years of service from RBL to the Armed Forces Community
- Despite Covid restrictions we held a centenary moment at the Cenotaph just as we had done 100 years before on 15 May 2021 led by our National President.
- A Message of congratulations from HM The Queen, was shared with Branches.
- We published our own book. We Are The Legion.
- We commissioned *Telling Our Story*, an initiative that encouraged shared memories of the Legion in the community. More than 5,000 items received across our membership, many shared on our website.
- We recognised 400 individuals as Centenary Stars who have made a difference to the Legion. Members, volunteers and employees.
- Westminster Abbey service in October, led by our Patron, The Queen with HRH Princess Anne, President of the Women's Section.
- A Festival of Remembrance that paid tribute to a century of the Legion, Remembrance, the Poppy.

• And many branches marked their centenary too with commemorations across the country.

### One Legion

- The Legion is unique as we say in the vision for One Legion, we are able "to bring together our nations, communities, and individuals to create better futures for our Armed Forces communities and their families."
- Some One Legion changes that have taken place so far:
  - We have been changing our welfare services, and how we offer them, to provide better support; increasing the limits for the Individual Needs Grants, increasing the Admiral Nurses, closing the Pop In centers, starting to define how we can create multi-disciplinary, expert teams to work with our case workers to make it easier for those who come to us. And we have been increasing our grants to other organisations.
  - Developed the New brand which will help us reach new people, in particular younger audiences who spend more time online and with digital media.
  - We have brought, Marketing, Remembrance, and Fundraising together in a single directorate to drive a more single-minded presentation of the Legion to all our audiences.
  - We will be moving MSOs to the Membership team and allowing them to focus on membership.
  - We have been building much greater expertise in areas of the organisation such as IT, Data; Membership Communication and Engagement (Internal Communications and Network Engagement will support going forwards).

## Highlights 2021

- Another very challenging year but again we have put our beneficiaries first and maintained our services and support, even doing more.
- Care Homes have had the hardest challenge with the pandemic, but they still maintain a level of services that we are extremely proud of
- Our branches working with branch community support ensured that your work supporting the communities goes on.
- We supported 30,000 people in need of help in the UK or one of 31 countries across the world where we operate.
- Through our caseworking, we provided practical support by awarding over 10,000 grants to individuals, helping with mobility, housing, household items and debt.
- Our War Pension and Armed Forces Compensation service received over 1,000 new requests for support with appeals against compensation awards. We supported them to secure over £2m during the year.
- We helped over 2,000 people through our specialist debt and money advice during the year, up 15% on last year, and securing nearly £10million for them.
- Our PAPP team ensured that this year's national census contained very important questions relating to the Armed Forces Count Them In next year this will provide some very helpful insight to the sector in the needs of our beneficiaries.
- We also made very good progress in our campaign to Stop the Service Charge for all those that have served with our Armed Forces.
- Our financial position also allowed us to support other parts of the sector that do vital work for those we serve, and we grant funded almost £10m ensure that work continues - £6m in particular to Combat Stress.

- None of this possible without your support of the Poppy Appeal.
- Difficult Appeal in 2020 due to Covid. Street collections fell to £19 million, but with Poppy Shop (£6 million) and online activity (£9 million) we raised £34 million.
- Thankfully street collections returned in the 2021 Poppy Appeal, and we could therefore raise our expectations and gave ourselves a £43m target. So far, we have banked over £22m across all areas of fundraising including £4m through contactless devices showing how important keeping up with the latest technology really is.
- On 6 June 2021, the 77th anniversary of D-Day, the British Normandy Memorial was unveiled at Gold Beach in France.
- The RBL provided a televised link from the unveiling to the National Memorial Arboretum for those veterans unable to travel to France.
- In 2022, focus will be the 40<sup>th</sup> anniversary of the Falklands.
- Tuesday, 14 June event for 10,000 veterans and bereaved families at the National Memorial Arboretum.
- Memorials at the Arboretum dedicated to units involved in the Falklands campaign and the Armed Forces Memorial records 255 fallen.

## **Diversity and Inclusion**

- Inclusivity is core to who we are and what we do at RBL. The Legion is unique in our ability to bring people together. Bringing people together is part of remembrance. It is core to who we are – each year we reaffirm our loyalty to community crown and nation.
- Members told us that they support diversity and inclusion and wanted the RBL to continue to evolve.
- We have appointed our first Head of Diversity & Inclusion.
- We have started developing and implementing our Diversity & Inclusivity strategy
- Are we reaching out to our communities for Remembrance? Are our events accessible to the disabled and mobility impaired? Are Branch positions offered to all?
- This work will ensure the Legion is understood and supported throughout its next century.

## Governance and Elections

- As we move away from our centenary, we need to focus on ensuring that our organisation is fit to keep up with the pace of change with the external environment. If you read the 'we are the legion' book the one thing that has been constant over the years is, Change. The Legion has always tried to keep up with the needs of our beneficiaries and the needs of the public in supporting our beneficiaries.
- Our Board of Trustees are doing exactly that with our Governance we have started to review our governance and we will be making sure that we keep you up to date with how that progresses.
- One change that the Board have introduced for the upcoming elections is to ensure that there is a suitable selection criterion in place for all candidates. This will help us find the most suitable people to lead and guide the country largest Armed Forces charity.

## Next Year 2022

- We approach 2022 with changes that come about from the pandemic as well as changes that we have approached through One Legion.
- But we approach 2022 with much to be positive about much of the change that we have started, particularly without teams and particularly with our focus on new expertise we should be able to provide much greater support, not only to our

members and volunteers whether you are in London, Cardiff or Belfast but more importantly to beneficiaries wherever they are based. It may take some time to work these changes through and ensure that they are well understood but hopefully we are all agreed on the outcomes that we are looking for.
