This year marks the 80th anniversary of several battles that led to the end of the Second World War, including the D-Day landings on 6th June 1944, the Battle of Normandy that followed, and the fierce fighting in the Far East in Kohima and Imphal. Throughout the year, RBL will be marking these anniversaries and paying tribute to those who paid the ultimate sacrifice and lost their lives, as well as thanking surviving veterans.

At the end of November 2023, RBL launched a campaign calling on the UK Government to appoint a Veterans' Commissioner for England. Veterans' Commissioners in Scotland, Wales and Northern Ireland are already dedicated to assisting and advocating for the veteran community.

More than 1,000 people signed our petition - your support helped us show the UK Government that RBL supporters back our campaign for a Veterans' Commissioner for England. Newport, Wales

We are also looking at how we can best communicate with the wider local community. Two of us are looking at completely revamping the Newport Facebook page, we'll look at getting on Instagram too.
