Our role in the Armed Forces Commissioner Bill

Angela Kitching, Director of Campaigns, Policy and Research (CPR), has recently represented RBL at a Parliamentary review of an important law establishing an Armed Forces
Commissioner, with broader powers to support the Armed Forces community and their families. Angela explained how the exciting new role could better address issues in the community such as finding housing, and stressed how strong partnerships with devolved administrations, metro mayors, local authorities, and NHS services are key to the role's success. The Bill is moving through Parliament and RBL will make sure our recommendations are heard and considered.


Lurgan and Brownlow branch recognises veteran's service

Branch members were joined by Armagh City, Banbridge, and Craigavon Borough Council, the Deputy Lord Lieutenant, and family members in a ceremony to remember Field Marshal Sir John Dill.

Born in Lurgan, Co Armagh in 1881, John was commissioned into the 1st Battalion The Leinster Regiment, saw action in the 2nd Boer War, the First World War (when he was awarded the Distinguished Service Order), and the Second World War where he commanded the 1st British Corps in France. He went on to be Chief of the Imperial General Staff. He is remembered for his role as the head of the British Joint Chiefs of Staff mission to Washington when he was the senior British representative on the Combined British and US Joint Chiefs of Staff Committee, and Winston Churchill's personal military representative in Washington.

His funeral was held on Wednesday 8th November 1944 in Washington National Cathedral with this ceremony at Lurgan War Memorial remembering his remarkable achievements and service 80 years on.
